Terms and Conditions

- ☞ In the event of any cancellation / postponement of the function after endorsing this contract, the following penalty charges will apply to the Client should the function be cancelled or postponed within the stipulated period from the date of banquet:
 - ⊕ Within 6 months – 50% of the guaranteed attendance
 - ⊕ Within 3 months – 70% of the guaranteed attendance
 - ⊕ Within 30 days – 100% of the guaranteed attendance
- ☞ Postponement of date will be subjected to date availability. In the event of such cases, the restaurant has the right to withdraw any discounts or promotions.
- ☞ An initial non-refundable deposit of \$4,280 is required to confirm the reservation, and a subsequent non-refundable deposit of the similar amount is required six months before the date of banquet. All outstanding balance for the banquet will have to be settled by cash or credit card.
- ☞ In cases where the designated function space is not available due to unforeseen circumstances, the restaurant reserved the right to transfer the Client's event to another alternative venue, without any change in menu price agreed to herein. However, the Client has the right to cancel the booking should the alternative venue be found unsuitable.
- ☞ The charges for the function will be based on the actual number of guests attending or guaranteed attendance committed, whichever is higher. Reconfirmation of the guaranteed attendance is required at least seven working days before scheduled function. Guaranteed attendance must be at least the minimum requirement of the standard package. In the event that the guaranteed attendance falls below the minimum requirement the restaurant reserved the right to impose a higher priced package or omit other discounts or promotion that have been committed initially in this agreement.
- ☞ The Client or any persons attending the scheduled function shall be responsible for any loss or damage to all restaurant property, and the cost of replacement or repair may be included in the final statement of account.
- ☞ The Client shall be responsible for all property (whether belonging to the guest or any other persons attending the scheduled function) placed, deposited, brought into or left in any part of the restaurant and the restaurant shall not be responsible for the safekeeping of custody of any guest's property. Under no circumstances will the restaurant make good or accept responsibility or liability in this respect.
- ☞ The Client shall not display any poster or other material within the restaurant premises without the expressed consent of the management. The Client shall not post, tack, screw or affix any display, labels or other decorative or promotional materials on any part of the restaurant premises. The Client agrees not to remove any furniture, fittings or other property from the premises in particular not to block fire doors and emergency exits.
- ☞ The Client shall have its guests, invitees and any other persons vacate the designated area at the closing hour indicated.
- ☞ The management reserved the right to stop any entertainment, game or other activity which in the restaurant's opinion is illegal, improper, indecent or unsafe or is likely to be a nuisance.
- ☞ Smoking is prohibited by law in the restaurant, smoking will not be allowed in the vicinity of the restaurant premises.



- ☞ At the end of each event, the client or organizer shall be responsible for removing all left over decorations, materials, props and other related items. If any items are not disposed off immediately after the event, the restaurant reserves the right to remove them with no claim. Any costs incurred by the restaurant in disposing the items will be charged to the client/organizer.
- ☞ No food may be brought into the restaurant from another source for service in our facilities. As for beverage service, all dispensing of beverage will be done by the restaurant's employees. Alcoholic beverages will not be served to anyone under 18 years of age without proper identification.
- ☞ Tung Lok Group of restaurants will endeavour as far as possible to provide the Client with their decided choice of menu(s). The management however, reserves the right to make any amendments or substitutions to the agreed menu(s) subject to its availability at any given point in time.
- ☞ In the event that the name of the chosen restaurant is changed or re-branded to another name belonging to the Tung Lok Group of restaurants, we reserve the right at our option to provide the function at the same premises under the re-branded or new restaurant name or provide an alternative restaurant within the Tung Lok Group of the restaurant, and in either case without change to the agreed menu and price.
- ☞ Complimentary use of the microphones, speakers, lighting or any equipment in the premises belonging to us during the event will be available on an as is where is basis. We do not warrant the working condition, functionality or fitness or suitability for the purpose for which equipment is required, regardless of whether any inspection or testing of the equipment has been carried out prior to the event. We will not held responsible or liable in any way for the malfunction or unused ability or unsuitability of the equipment during the event or any part thereof, whether due to the fault or neglect or otherwise of our staff, servants or agents.
- ☞ With respect to music or entertainment that is not approved by us ("Non-Approved Music and Entertainment"), unless otherwise agreed in writing by us, the Client shall be solely responsible for and bear all costs for obtaining the necessary licences, authorities and consents for Non-Approved Music and Entertainment intended to be played reproduced by any media whatsoever at the venue in respect of the event or provision of the services at the venue. We reserve the right to refuse or not to permit the reproduction of Non-Approved Music and Entertainment at the venue during the event or provision of services, unless proof to our satisfaction that the requisite licences, authorities and consents have been obtained by the Client. The Client agrees to hold us harmless against and indemnify us for any claims, demands and actions taken against us and for all costs and expenses (including legal costs and expenses on an indemnity basis) incurred in respect of such claims, demands and actions in connection with relating to or arising from the reproduction of Non-Approved Music and Entertainment at the venue during the event or provision of services."
